Jeffrey Kittel had submitted a contract renewal for another two years. This upcoming year is the final year of his three-year contract. The board determined that next year, after Jeff's final contracted year, the position should be reconsidered and opened up for bids. Jeff to be notified of the plan. Lost Nation Bridge. It's recommended to get bids from Cody at Tatro's for this bridge and also Waterville Mtn. Road.
